Arizona State Parks Rules and Regulations will be observed. Proposed changes in your schedule or activities must be pre-approved by the Park Manager or his representative.

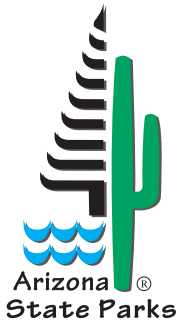

# Wedding Package Options

The Wedding Package includes the following:

1. Wedding Site, \$25.00 (your choice in the orchard or a ramada)
2. North Ramada \$20.00 (wedding or reception area) (occupancy: maximum 70).
3. South Ramada \$20.00 (wedding or reception area) (occupancy: maximum 70).

**Fees are non-refundable, payment due within 10 days of Request to Hold Reservation.**

The standard Park Entrance Fee will be charged in addition (for the wedding and the rehearsal), which is \$8 per vehicle for up to 4 people per vehicle. Special arrangements or the use of vouchers can be made for payment of the Park Entrance Fee. Please be aware that the gate fee applies to everyone.

# Wedding Permits

1. The Park Manager may require a permittee to post a deposit against damage and clean-up expense, special insurance, and provide adequate medical, sanitary, and security services during the term of the Wedding Permit. Damage deposits will be retained when, in the judgement of the Park Manager, facilities are not left in the same conditions as when the activity commenced.
2. Persons entering a park under a Wedding Permit shall be subject to all applicable park user fees and rules.
3. If the permit approval turn-around is needed within 48 hours of the actual time of use, an additional \$100 is added on to the fee.
4. If the use of the park requires any waiver of existing Arizona State Parks Rules concerning use or manipulation of the park facilities, development or resources, an additional \$100 is added on to the fee.
5. The Park Manager may deny a Wedding Permit, which otherwise meets requirements of WKLWUOHROIRUKHDOWKDGMDIHWUHDVRRUWRSURWHEFWWKHSDUNIURPMLJJBHUPWVMDUHHJUDWHGRDUVWERPHUVMHUYHGEDVLMEMHEFWWRWKHMWDW rule.

## Rules and Regulations for Slide Rock State Park

1. All disposable items that are brought onto the park property must be taken out when you leave.
2. **Pets must be kept on a leash, and are prohibited in the swim area.**
3. Radios and other sound producing devices must be kept on an individual hearing level
